- Introducing a Student Government Representative: Ahmadzai Zarlasht
- PLO Review Tutoring Theory and Practice, NCL:
  - Met with faculty and faculty agreed with the following changes; chair has implemented changes in Meta:
    - Question about the term "assets"- it reflects shift from deficit-focused outcome.
    - Agree to remove "explicitly" and add "in their subject" to end of outcome.
- Two workshops at Flex Day; one in afternoon/one in morning; coordinators should be present. Workshop will include how to set up assessments and how-to basics, as well as troubleshooting.
- Meta concerns access for SLO coordinators, discussion regarding what level of access. Since SLOs have not been mapped to PLOs, will this initiate a curricular change, and how we will avoid that. Will be asking Meta if access can be given to SLO Coordinators and only within the SLO tab in Meta. Coordinators will need to manually map SLOs to PLOS.
- Meta PLO Assessment Update: course tables are not combined; want one aggregate from all courses for one PLO.
- Data export function is not intuitive, work in progress.
- SAOs will be discussed at next Assessment meeting with Meta.

7.1. SLO Committee and Accreditation Midterm Report

- Request for shared governance committee participation
- Midterm Accreditation Template; specifically mentions student outcomes in some sections. Since SLO committee doesn't handle SLOs directly anymore, the scope is limited; however, Program Review Committee has a better scope because of their exemplary reviews. SLO Committee can better contribute to the report with its decision to move towards Meta for Assessments. Assessments is able to provide disaggregated data and this data is more helpful for coordinators to be able to pinpoint improvements with teaching overall. The benefit of switching from eLumen to Meta has the potential to also map ISLOs, PSLOs, and CSLOs together, and keeps all the SLO data in one program across the institution.
  - JH: should we discuss adding the review cycle process? JR: yes, focus on the alignment of assessing and analyzing data, along with program review. MM: the contribution of SLO Committee can just be added, don't necessarily need to worry about coming up with a full answer to each section. JR: agreed, craft a short narrative to add to present to VP Ho.
  - JH: our contribution to the report seems process-oriented based on other committee findings/roles etc. SLO Committee can focus on institution's process versus being data-driven; what SLO Committee does making the SLO/Curriculum process more user-friendly and efficient
