# Committee Comments:

# 7. Discussion Items

7.1. LPC Associate Degree General Education

• Minimum Grades

Committee Comments:

- What does Chabot require vs. what we require, how will it impact students, does it matter?
- STEM: faculty felt like it would be helpful for students if we were in alignment with Chabot.
- We are not aligned with Chabot for 24-25, but once we align with Title 5 (we approved already), in Fall 2025 we will be in alignment with Chabot.

- Counseling seems to overwhelmingly want C or above in English 1A and Math, not the courses in Areas 1-6.

- A&H feedback, repeated request for data on these topics/questions, and didn't think it was important to match with Chabot.

- Faculty should go back to divisions with these 4 options: Ds in all areas, C in Area 1a only, C in Area 1A and 2, C in 1-6, and remind divisions what we currently do (C or above in 1A and Math proficiency, otherwise D or above in all areas) and what we passed for Fall 2025 (Ds in all to be in alignment with Chabot).

- Minimum units for courses for GE areas: students should be able to fulfill a GE req with ONE course. MUS and BIO have 2-unit courses, and then there are a bunch of 1 unit lab courses. -Craig Kutil will propose a change to this with the new GE Associate Degree pattern.

### 7.2. Minimum Grades for Courses in a Certificate

## Committee Comments:

- LPCSG feedback: getting a C is the bare minimum when/because certificates are important. Student Govt students are usually high achievers.

- Division Meetings feedback: STEM feedback is that C or better seems appropriate, certs align with major requirements. BISL and PATH joint meeting feedback is that for AA and GE, requiring a C or better makes sense, was some confusion around overall GPA requirements. A&H feedback was a repeated request for data on these topics/questions, and that faculty didn't think it was important to match with Chabot.

- P / NP vs. letter grade courses; NP = below a C. We probably need Cs or better on our certificates.

- We don't have data on how many students have e.g. 1 D in their major. They can retake the course.

- Nan Ho: Checking in with CTE Advisory Boards, they have expectations around what the certificate means, should require, etc. What do those Advisory Boards expect, what do students in the program expect?

- Joel Gagnon did some research – most other local/wider Bay Area CCs require a C or higher for certs; fewer schools require a certain overall GPA for certs. Should we ask CTE students for feedback on this issue?

- Because faculty seem to overwhelmingly want to have a C or higher on courses required in the certificates, Craig Kutil will go forward with that.

Nan Ho: Two people going to Merritt College fall Curriculum Institute. Last week, we submitted a program report to ACCJC.

Craig Kutil: A lot of programs will be over 60 units, so he will notify those programs that they might want to update. Program Maps (AA/AS degrees) will have to be updated. AD-Ts as well. Asks committee to please be careful with tech review for Equity Considerations: check that course outline of record shows what the proposal says in their Equity Considerations.

8.3. Articulation Officer's Report -

October 21st, 2024 | 2:30-4:30 PM | Room 21211

Craig Kutil: No policy for articulation based on CCN templates. All 6 of our CCNs are also being submitted for UC transfer and Cal-GETC review. People are upset because the CCN doesn't guarantee articulation. All AOs of CCCs, CSUs, and UCs met and had a heated discussion. Some major CSU feeder schools are very upset about Cal-GETC, upset about Cs or above for transfer, and upset about CCNs. Academic freedom in peril for CCN courses since templates would have to be exactly the same in order for UC to consider UC transfer and Cal-GETC articulation for CCN courses. Cal-GETC will hopefully meet soon. Social Justice templates are being reviewed along with Elementary Teacher. Revised ADT for Environmental Science, Physics ADT is in review, but both are very high units.
