Veterans First Program Accomplishments Fall 2023 - Spring 2024

Mission Ready Learning Community Fall 2023

The Veterans First Program completed our second year of the Mission Ready Veterans Learning Community during Fall 2023. Mission Ready Learning Community brought together a group of student veterans to create a more cohesive and interactive learning environment where we strive to provide student veterans with a veteran friendly space to learn and meet their academic goals. Mission Ready students participated in English 1A (course code 22776, instructed by Professor Jim Ott, and Communications 1 (course code 23461), with Professor Dobson.

Operation Gateway Summer 2023:

Operation Gateway #15 - New Student Veterans Orientation was huge success! Over two days – July 27 and 28, 2023, over 31 new student veterans and military affiliated students participated in Operation Gateway. Of the 31 students enrolled, they were enrolled in 107 unique courses with a 78% pass or success rate for Fall 2023.

Overview of Operation Gateway included the first day covering campus resources where students visited with the Library, Computer Center, Tutorial/Reading and Writing Lab, Disability Student Program and Services, Career Center, and Financial Aid. Day Two focused on resources specifically for veterans. Students received a

checklist of requirements to ensure compliance with utilizing their VA Education Benefits, met with a Veterans Counselor and Certifying Official. Students also networked with professionals in industry and community veterans service organizations during the Friday Resource Fair.

Comments from participants - What was most impactful about Operation Gateway?

"The whole two days was great learned so much about resources available to us as students." (Jovan P. – US Army Veteran)

"The most impactful experience for me was learning about the different programs. I can reach out to pay for my education and my family's. I was particularly interested in the CalVet Fee Waiver, as my son would be eligible to use it under Plan B." (Jarad W. – US Army Veteran)

"The constant message of asking for help was the most impactful from hearing it from different people. When a lot of veterans are independent, the openness of using your resources may persuade them to ask for help earlier rather than later." (Vivian C. - US Army Veteran)

"As a veteran student who had already achieved an associate's degree at another community college where there was no real support for veterans The LPC veterans first program is completely 180 degrees from any support that I would have received before I am so grateful that I found this program and I look for now to going back to college and getting more experience as to where before I didn't want to go back to college I struggled it was very hard I was left on my own to figure everything out." (Noah K. – US Army Veteran)

"Chapter Benefits explained. emphasis on services are here for the Veteran, services go away if not used. There is no reason to feel guilty to use so many available resources." (Richard A. – USMC Veteran)

College Planning Priority "Student Success & Completion" (continued)

- UC Berkeley Campus Tour: The Veterans First Program held a UC Berkeley Veterans Transfer Tour on October 13, 2023 where our Veterans Counselor coordinated a prospective student transfer tour of the UC Berkeley campus. The campus tour gave veteran students a chance to explore the campus and get a firsthand view of the college and programs offered. Our host, Luis Hernandez (Program Director / Academic Achievement Counselor) provided a tour of UC Berkeley classrooms, favorite campus hangouts, and notable campus landmarks. Most importantly, he answered our questions about the transfer process, academic programs available and the process of assimilating to a large campus. Being able to tour a prospective campus and understand the culture and community really helps students as they are making their decisions to transfer.
- SJSU Transfer Tour: The spring semester also enabled the Veterans First Program to offer students the opportunity to visit and tour San Jose State University's campus on March 8th, 2024. The group of students were greeted upon arriving at San Jose State's campus by their very own Veterans Resource Center's staff at SJSU, followed by a tour of the campus and visit with staff at the SJSU Veteran Center.
- Veterans First Program Open House: In January and May, 2024, we held a Veterans First Program Open House. Each session, over fourty new student veterans attended the session. At Open House,

each student received a personal orientation from each staff member. They met with the Veterans Counselor Assistant on how to login with their student ID when they visit the Veterans Resource Center, reps from the Student Veterans Organization leaders on how to get involved, the Veterans Specialist on how to use VA education benefits, the Veterans Counselor on the advantages of having a comprehensive education plan. They also met with a representative from the Financial Aid Office and the Disability Student Program and Resources office. Students all received a \$100 credit from the LPC Bookstore.

• Spring 2024 - Career Search Series: City of Livermore, Livermore Police Dept, TESLA, Homeland Secruity, LLNL. For the spring semester, the Veterans First Program hosted a variety of potential employers. The city of Livermore, Tesla, Homeland Security, and Lawrence Livermore National Laboratories. All came by to inform the student veterans of potential employment opportunities as well as feedback on resumes and interview questions that the student veterans would potentially face. This resulted in great networking between the college and the community. We are looking forward to hosting them again.

College Planning Priority "Health and Wellness"

During the Fall 2023 Semester, we offered the following programs which focused on Health and Wellness:

- Our annual 2.2 for 22 Challenge for Veterans was held on October 21, 2023. The primary goal of the 2.2 for 22 event is to raise awareness about the distressing fact that 22 veterans succumb to suicide each day. While the event initially focused on engaging the Las Positas College community and the local area, it became evident last year that the message resonated well beyond these boundaries. Over 100 people participated in activities that challenged their minds and bodies including 22 unique challenge stations. Young and old had fun doing activities for 22 seconds or 2 minutes. Challenges included a 22 second Dance Off, Hula Hoop Challenge, Chess Challenge, Hammer Swing Challenge and Dummy Drag Challenge to name a few. Funds raised went toward scholarships and programs to promote mental health and life/college balance.
- Community Engagement Our office hosted Veterans Affairs Commission for Alameda County September 18, 2023. This Town Hall meeting brought the community to Las Positas College. In this meeting the board and community discussed various ways to further support veterans in the community. In addition to discussing resources and assistance for veterans, we also discussed community and college events that were coming up.
- Student Veterans Organization held its annual Fall 2023 SVO Trunk or Treat Involving veterans' families created a fun, healthy safe environment where students were able to bring their children to campus. The campus and Livermore community were dressed in their scariest and silliest costumes to participate in the fun. Student Veterans Organization members decorated their car trunks with Halloween decorations and lots of candy. Each member was dressed in costume to promote the holiday.
- Our Program hosts monthly visits from the Palo Alto VA Heath Mobile Outreach Unit and CAL VET. The veterans first program continues to strengthen its relationship with the VA. The Palo Alto's mobile VA unit came to campus once a month to support the veterans first program and they did so by

providing P.A.C.T Act Screenings, checkups, Overall VA healthcare information and signing up new student veterans for health benefits with the VA. The VA Palo Alto mobile team has a significant amount of knowledge about the VA health system and they do a great job at passing down that information to the student veterans.

College Planning Priority "Equity"

• Veterans Day Events:

The Veterans First Program partnered with various community groups to recognize and celebrate the service of our veterans. Our final event of the month was a presentation focusing on "Honoring Our Heroes." This event was held in the Mertes Gallery on campus and featured military photography from Vietnam Veteran/Photographer Steven Burchik. During the celebration we recognized three essay contest winners who wrote about their military journey "A Hero's Journey." Congratulations to essay winners Siera Johnson, US Navy Veteran; Aurelio Antonio Sandoval, US Army Veteran; and Jarad Westfall, US Army Veteran. Essay awards were sponsored by the American Legion Post 246 and Blue Star Moms. We appreciate their continued support of veterans!

We also presented five "Quilts of Valor" to veterans. "Quilts of Valor " is a handmade quilt presented by the Amador Valley Quilters to a service member or veteran who has been touched by war. The recipients are either students, alumni or staff of the Las Positas College Veterans First Program. All combat veteran, and proud of your service to our country. Handmade quilts were presented to Gisella Agurcia – USMC Veteran, Edgar Reyes-USMC Veteran, Jovan Pierre-US Army Veteran, Trevor Penero – US Army Veteran, and Richard Arredondo – USMC Veteran.

- Remembering 9/11 Event: Author and historian, special guest speaker Dr. Harold Strunk, an Army/Navy veteran, shared an abundance of knowledge, experience, and personal account of events leading up to the September 11 attach on America. Veterans, community members, and students enrolled in History and Political Science courses attended his presentation. He spoke from the heart, was riveting and engaging! He challenged the audience to look into the events that surrounded that historical and heart wrenching event with more detail. Dr. Strunk joined us for lunch and was happy to answer any questions the community had. The goal for this event was to remind the community that freedom comes with sacrifice, and that we must honor those who pay the ultimate price for it. Special thanks to VFW 7265 for the presentation of colors and Ms. Anastasia Pono for singing the national anthem.
- Honoring Women Veterans (Spring 2024): March is federally recognized as Women's History Month. During this month, Las Positas College's Veterans First Program proudly holds an event that acknowledges and honors the hard work and sacrifices of women veterans recognizing and celebrating their contributions to our community and nation as a whole. The twelfth annual "Honoring Women Veterans" event was held from 4:00 p.m. to 6:30 p.m. on Thursday, March 28th, in room 2401 of building 2400. Keynote speakers, including Lt. Col. Marisol Chalas, the first Latina National Guard Blackhawk helicopter pilot, and Virginia Wimmer, the Deputy Secretary of Women Veterans Affairs at the California Department of Veterans Affairs, attended the event and delivered motivational and powerful speeches to the audience. Scholarships were also given out during the event and were given by organizations such as the Valley Veterans Foundation (VVF), Blue Star Moms (BDSM), Josefa Higuera

Livermore Chapter of the Daughters of the American Revolution (DAR), and Veterans of Foreign Wars (VFW). Organizations such as the Valley Veterans Foundation (VVF), Blue Star Moms (BSM), the Josefa Higuera Livermore Chapter of the Daughters of the American Revolution (DAR), and the Veterans of Foreign Wars (VFW) awarded scholarships to women veterans during the event. Some of the recipients included Lilia Venegas, a current student here at Las Positas College and a U.S. Army Veteran, Siera Johnson, also a current student and a U.S. Navy Veteran, and Adriana Santos, who is an alumnus for Las Positas College and a U.S. Marine Corps Veteran. To top things off, the event included a Quilts of Valor presentation, honoring women that have served in the military.
