ISLOs

a. LPC Graduation Survey

- This is an exit survey, given to students every other year.

- Stuart's comment/share: Our GE Philosophy is dated. ISLOs /Title 5 /GE Philosophy should all be consistent. Ex: The one about wellness in the GE Philosophy. We should aim to do this soon and for all future ISERs.
- Per Chair: This work should not be done in a silo. We need to work across offices/groups, incl. with LPC Student Government.
- Chair will meet with Rajinder to discuss if we can survey more often.
 - o Per Stuart: Survey for *new* students (entry survey) could provide a baseline to compare the results with the graduation survey.
 - o Per Ann: It's tough to know what you don't know though...
 - o Per Thomas: How about after the 1st semester? Then students know a bit more about expectations, etc.
 - o Per Robin: How to make the results meaningful, e.g., tying a specific SLO from a course to an ISLO /give GE faculty the survey to administer to their students in the beginning? Then students can report on things when they're fresh in their mind (vs. 2 years later).
 - o A survey could complement mapped ISLOs (per Stuart). After Liz/Ann's meeting with Rajinder, a short presentation at Academic Senate would be good (plan for presentation, include Curriculum Chair).

b. CSU General Education Breath Certificate of Achievement

- Legislation just passed in CA – common course numbering, common GE requirements across CSU & UC.
- Whose responsibility is the GE Philosophy?
 - o Per Kristina: Maybe Curriculum Committee & Academic Senate. This really should align with the ISLOs. ISLO changes should be a campus-wide conversation. Advisory working group (per Chair)?
 - o Per Stuart: This seems like a 10+1 area for Academic Senate (leading the task force). Discussions could occur at a Town Meeting [breakout sessions], Curriculum meeting, Academic Senate, Division meetings, LPCSG meeting. This would allow all a chance to weigh in.
