#### 7.1. CurriQunet META Fall Assessments and Updates

- Disaggregated data became useful once student information was entered, allowing for meaningful observations to be drawn.
- Outcome data is not immediately visible unless the dropdown menu is selected, highlighting the need for additional faculty guidance on navigating the system.
- Faculty would benefit from clearer instruction on assessment criteria and rubric development.
- Assessments should focus on whether students are achieving the outcome, rather than how well they are performing; most students should be categorized as developing or completing the SLO.
- Coordinators should encourage faculty entering section-level data to review and reflect on the results more closely.
- Data upload issues are still being addressed.

#### 7.2. Spring Flex Day Session

- Incorporate program-level assessments.
- Provide additional faculty training.

- Offer two one-hour training sessions; one morning and one afternoon.

### 7.3. SLO and Accreditation

- Drafted content for the Accreditation Committee's Midterm Report, including information on a new approach LPC is using to assess outcomes.
